To all to whom these Presents
shall come greeting, In the name
of God Amen,

I Robert Goodall of the Parish
or Township of Cubley in the County
of Derby, being sound in Mind, Thanks
be to God for the same, do make and
ordain this my last Will and Testament
in Manner following

First, I order that all my just debts and
Funeral and Testamentary expences be
paid by my hereinafter named Executors

And I give and bequeath unto my
Dear Wife Mary Goodall after the above
expences are paid, The whole of my live
and dead Farming Stock, Implements of
Husbandry, Household furniture, ready money
and Farm Produce and other effects now
upon the Farm situate at Cubley aforesaid
in my occupation,

And I further give and bequeath unto
my dear wife Mary Goodall, All those two
messuages or Cottages of mine together with the
Yards, Gardens, and appurtenances belonging
thereto situate in the Parish of Shirley in

The County of Derby aforesaid,

And it is further my request that the sum of
2 Three Hundred pounds now borrowed upon the
Stock upon the Farm in my occupation, and
one Hundred pounds upon the cottages aforesaid
shall be paid out of the stock now upon the
Farm. And I further request and desire that
a Valuation of the Stock and other effects upon
the Farm belonging to me be Valued by a fair
Valuation as soon as conveniently possible -
after my decease and that the profits of the
Farm if there be any during the term of the
tenancy of my executors be fairly and equally
3 divided into two moieties, one moiety to my
Dear wife Mary Goodall, and the other moiety to
my two sons Joseph Goodall and Henry Goodall,
Share and Share alike so long as they continue
together on the said Farm with my wife Mary
Goodall, and in case of either of my two sons
Joseph Goodall and Henry Goodall removing
from or leaving the said Farm then for their
share, or shares of the profits aforesaid, after
such removal to become and be at the
disposal of my dear wife Mary Goodall as
4 she may think most proper, from the time of
such removing or leaving as aforesaid.

And it is further my request and desire that A. C.
Howard Esq^r my Landlord be requested and will
have the kindness to accept of my Executors and my
two sons Joseph Goodall and Henry Goodall as his
future tenants after my decease;

And I do hereby nominate constitute and appoint
my dear wife Mary Goodall sole Executrix of this my
last Will and Testament, hereby revoking and making
void all others by me made
