In the name of God Amen. And the Twentieth day of May in the fifth year
of our Sovereign Lord George the Second by the grace of God of Great Britain France
and Ireland King Defender of the faith and so forth. And in the year of our Lord
God one Thousand seven hundred forty & four. I John Slater of the Liberty of Belper
in the parish of Duffield, and County of Derby, yeoman, being weak in Body
but of sound and perfect mind and memory, I give to the most Excellent
Almighty God, to make and ordain this my present Last will and Testament
in proper form following, that is to say first and principally I commend
my soul into the hands of Almighty God hoping through the merits Death and
Passion of my Saviour Jesus Christ, to have full and free pardon of all my sins
and to inherit Everlasting Life, and my body I commit to the earth to be decently
Buried, at the Discretion of my Executors herein after named, and as Touching
the Disposition of all such Temporall and worldly Estate as it hath pleased
Almighty God to bestow Upon me, I dispose thereof as followeth First I will
that all my debts and generall Charges be well and faithfully paid, and
discharged, also I give and bequeath all my Copy hold Lands Lying in Hushwood
to my nephew Isaac Slater, but if the aforesaid Isaac Slater should die without
Male issue then my mind and will is that my nephew John Slater
shall Enter upon and Enjoy the said Copy hold Lands his heirs or assigns forever
provided the aforesaid Isaac Slater pay to my now Loving wife Elizabeth
Slater the Sum of Eight pound every year during the term of her naturall
Life by two Equal payments to wit on the Twentieth day of September and
the five and twenty day of March but if my said wife shall happen to marry
then my mind and will is that my said nephew Isaac Slater shall pay but four
pound yearly to my said wife and my mind will is if that my said nephew
Isaac Slater shall Refuse or neglect to pay the aforesaid Sum of Eight pound
yearly that my now Loving wife Elizabeth Slater shall Enter upon and
Enjoy the said Copy hold Lands during her naturall Life, also I give and
bequeath to my said Loving wife Elizabeth Slater the House and Land which
I now have in possession with all the Appurtenances to it belonging with all House
hold goods except the best bed but one with all the Corn Chies & Bacon therein
Contained at my Decease. Also I give and bequeath all my Copy hold Lands Lying in
Belper to my niece Ann now wife of Nathaniell Bowmer her heirs and assigns
for ever provided that the aforesaid Nathaniell Bowmer do pay to my now Loving
wife the Sum of three pound Every year during the term of her naturall
Life by two Equal payments to wit on the Twentieth day of September and the
five and twenty day of March and my mind will is if that my said nephew
Nathaniell Bowmer shall Refuse or neglect to pay the aforesaid Sum of three
pound yearly that my now Loving wife Elizabeth Slater shall Enter upon
and Enjoy the said Copy hold Lands during her naturall Life, also my will
and mind is that my nephew Isaac Slater shall pay into John Bowmer and
Elizabeth Bowmer the Sum of twenty pound Each within four years after
my wife decease out of the Copy hold Lands Lying in Hushwood aforesaid
but if either or both of the aforesaid John Bowmer and Elizabeth Bowmer shall
happen to die before the time above mentioned, then my will and mind is that my
said nephew Isaac Slater shall pay that share or shares to Ann now wife of Nathaniell Bowmer her heirs or assigns

Also my will and mind is that my Nephew Isaac Slater shall pay unto my
nephew David Slater the Sum of fifteen pound out of the Copy hold Land Lying in
Hawthorn ten years after my decease Also give and Bequeath to my wife the best
Cow I have, Also give and bequeath to my said Living wife the Sum of twenty pound
to be paid her by my Executors within Twelve months after my decease,
Also I give and bequeath to Ann Bowmer the best bed but one in my House,
Also I give and bequeath to David Slater fifteen pound to be paid by my
Executors within one year after my Decease, Also I give and bequeath to John
Slater thirty pound to be paid by my Executors within one year after my Decease,
Also I give and Bequeath to Samuell Slater fifteen pound to be paid by my
Executors within one year after my Decease, Also I give and bequeath
to Hellen Slater fifteen pound to be paid by my Executors within one
year after my decease, Also I give and bequeath to Elizabeth Slater fifteen
pound to be paid by my Executor within one year after my Decease,
But if any of the aforesaid David Slater Samuell Slater Hellen Slater
or Elizabeth Slater happen to dye before the said Legacy be paid, then
my mind and will is that the said Legacy shall be paid to the Survivors,
Equally betwixt them, Also I give and bequeath to Thomas Slater of Turv
Ditch fifteen pound to be paid him by my Executors within one year after
my Decease, Also I give and bequeath to my Sister In Law Martha Slater
five pound to be paid by my Executors within one year after my decease,
Also I give and bequeath to Elizabeth Sikes daughter of Ann Sikes ten pound
to be paid by my Executors within one year after my Decease,
Also I give and bequeath to Mary Barker and Ann Barker of Thelton
Each of ^{thirty} fifty Shilling to be paid by my Executors within one year after my Decease,
Also I give and bequeath to my Brother Thomas Slater his four Children
William Slater Ann Slater Grace Slater and Thomas Slater the Sum of
five pound apiece to each one of them to be paid by my Executors
within four years after my Decease, Also I give and Bequeath to my
Brother Thomas Slater one Shilling to be paid by my Executors, Also I give
and Bequeath to my Brother Joshua Slater one Shilling to be paid by my
Executors, Also I give and bequeath to Joseph Fox of Matlock five pound
to be paid by my Executors within one year after my Decease,
Also I give and bequeath to Ann Topleis Daughter of William Topleis of Shottle
the Sum of five pound to be paid ~~to~~ her by my Executors within one
year after my Decease, Also I give and bequeath to John Allson Shoemaker
fifty Shilling to be paid by my Executors within one year after my decease,
Also I give and bequeath to William Fox Shoemaker fifty Shilling to be paid
by my Executors within one year after my Decease, Also I give and
bequeath to Samuells Fox fifty Shilling to be paid by my Executors
within one year after my Decease,

Also I give and Bequeath to John Fox the Sum of Thirty Shilling to be paid by my Executors Within one Year After my Decese. Also I give and bequeath to Mary wife of Thomas Dakly Thirty Shilling to be paid by my Executors Within one Year After my Decese. Also I give and bequeath the Sum of forty pound to the poor of Belper to be paid by my Executors In Manner Following to wit that the Said Sum of forty pound be Laid out on a piece of Land As soon as may be And Rent thereof to be Dealt yearly on the first day of February by the then Present Overseers of the poor of Belper, And my mind and will is that My Executors shall pay Interest after four pcent Untill the Said Sum of forty pound be Laid out as aforesaid to be Dealt as above mentioned. All and Singular the Rest and Residue and Remainder of my Estate Reals and personalls whatsoever I give and Bequeath to my Nephew Isaac Slater and Nathaniel Bowson Whom I ordain Apoint and Constitute full and Joynt Executors of this my presents Last will and Testament And Lastly I do hereby Revoke annul and make voids all former wills by me Heretofore made or published in Witness whereof I have put my Hand and Seal to this my Last will and Testament Contained In two whole Sheets of paper And this part of a third Sheet of paper the day and Year In the first Sheet above written.
