This is the last Will and Testament of me Francis Spencer of Muddleton by Workswoth in the County of Derby. I give and bequeath all my personal Estate and Effects whatsoever and wheresoever and of what nature or kind soever the same may be unto my Sons James Spencer and William Spencer and my daughter Mary Spencer equally amongst them share and share alike Subject nevertheless and charged and chargeable with the payment of all my just debts and funeral and testamentary expenses and the costs and charges of proving this my Will and which I will and direct shall be paid by them in equal shares and proportions I give and devise all that dwellinghouse or tenement situate standing and being in Muddleton aforesaid with the stable and appurtenances thereunto belonging and wherein I now dwell And also all those two closes pieces or parcels of land or ground situate lying and being in Workswoth aforesaid and called or known by the respective names of the Tree Close and Overholes with the thrashing Barn standing thereon and now in my possession unto my said Son James Spencer his heirs and assigns for ever I give and devise All those two Closes pieces or parcels of land or ground situate lying and being in Workswoth aforesaid commonly called or known by the several names of the Near Close and the Beer Single and now in my possession And also the lower part of the Close called the Muldier Bushes And also the right Court adjoining my now dwellinghouse and which I direct to be squared off from the stable gable and adjoining thereto unto my said Son William Spencer his heirs and assigns for ever I give and devise all those allotments plots pieces or parcels of land situate lying and being on Muddleton aforesaid and now in my possession unto my said Sons James Spencer and William Spencer and to their respective heirs and assigns for ever to take as tenants in Common and not as joint tenants I give and devise all the upper part of all that said Close piece or parcel of land situate at Muddleton aforesaid called the American Bushes unto my said daughter Mary Spencer and ^{and my said two Sons James and William Spencer their heirs and assigns for ever} I give and devise all that allotment plot piece or parcel of land situate lying and being on Muddleton in Workswoth aforesaid and now in my possession unto my grandson Francis Spencer his heirs and assigns for ever I give and devise all those two Closes pieces or parcels of land situate lying and being in Muddleton aforesaid called by the respective names of the New Close and Middle Ditch Single unto my said two Sons James Spencer and William Spencer their heirs executors administrators and assigns Upon Trust that they my said Sons or the survivors of them or the heirs executors administrators or assigns of such

6 I do and shall at the expiration of two years after my decease absolutely
sell and dispose of the said close pieces or parcels of land called the New Close and
Middle Ditch Single either by public auction or by private contract to any person or
persons who shall become the purchaser or purchasers thereof and I do hereby will
order and direct that the receipt or receipts of my said Trustees their executors
administrators or assigns shall jointly or severally be a good and sufficient discharge
and discharge to a purchaser or purchasers thereof for all such sum or sums of money
7 as they shall receive touching the trusts hereby in them reposed, and that my said
Trustees shall reimburse himself and themselves for all moneys costs charges and
expenses that they or either of them shall be put unto touching the trusts aforesaid
and that they shall not be charged or accountable for any more moneys than shall
come to their respective hands on account of such aforesaid trust hereby reposed in
them, but that they my said Trustees their executors administrators and assigns
8 shall receive the rents issues and profits of the said close called the New Close and
Middle Ditch Single until the same shall be sold by them and for their own absolute
use and benefit And it is my will and I do hereby direct that in case the money
arising from the sale of the said close shall not amount to the sum of two hundred
pounds then and in that case my said Trustees their executors administrators or
9 assigns shall make up such deficiency by advancing such sum or sums of money
equally between them as will make up the said sum of two hundred pounds and
I give and bequeath the said sum of two hundred pounds unto my four
daughters, namely, Elizabeth the wife of David Gutter, Blacksmith, Hannah
the wife of Caleb Moore, Grocer, Ann the wife of Thomas Beeton Joiner and
Ellen the wife of James Elie of Muddleton aforesaid Annis equally amongst them
share and share alike and to their respective executors administrators and assigns
And Lastly I do hereby nominate constitute and appoint my said two Sons
10 James Spence and William Spence Trustees and Executors of this my last will and
testament hereby revoking all former and other wills and Wills by me at any time
heretofore made and declare this only to be my last In Witness whereof I the
said Francis Spence have hereunto set my hand and seal this twenty ninth
day of February - in the year of our Lord one thousand eight hundred and thirty six.

This is a Codicil to be annexed to and taken as part
of the last will and Testament of me Francis Spencer
of Middleton by Wiltsworth in the County of Rutland and
bearing date the twenty ninth day of February one thousand
eight hundred and thirty six. Whereas since the date of my
12 said will I have sold and disposed of the piece of land lying
upon Middleton in Wiltsworth aforesaid and which I had
given and devised to my Grandson Francis Spencer his heirs
and assigns for ever Now I do hereby give and bequeath to
my said Grandson Francis Spencer and also to my Grandsons
James Spencer and Thomas Spencer the sum of Fifteen pounds
six shillings and eight pence each and to be paid to them
when they shall severally and respectively attain the age
13 of twenty one years. I hereby revoke the bequest in my
said will mentioned of the sum of fifty pounds each to my
daughters viz. Elizabeth the wife of David Gratton Hannah
the wife of Paul Snow Maria the wife of James Rose and
Ann the wife of Thomas Deaton, and do hereby give
and do hereby give and bequeath to them respectively the
sum of Forty pounds and to be paid to each of them
as in my said will is mentioned instead of the sum
14 of Fifty pounds. And I do hereby confirm my said
will in all other respects whatsoever. As witness my
hand this eighteenth day of February in the year of
our Lord one thousand eight hundred and forty one.
